6. The Defendant is not indebted to the Plaintiff.

As and for a Fifth Affirmative Defense

7. The Defendant has no contractual relationship with the Plaintiff.

As and for a Sixth Affirmative Defense

8. The Plaintiff lacks privity with the Defendant.

As and for a Seventh Affirmative Defense

9. The Plaintiff did not purchase any quantum meruit or unjust enrichment claims against the Defendant.

As and for a Eighth Affirmative Defense

10. The Plaintiff lacks legal capacity or standing to sue Defendant.

As and for a Ninth Affirmative Defense

11. The Plaintiff lacks legal capacity or standing to sue Defendant because the Plaintiff is not licensed as a "debt collector" by the City of New York.

As and for a Tenth Affirmative Defense

12. The Plaintiff lacks legal capacity or standing to sue Defendant because it is a foreign limited-liability company that is not authorized to do business in New York and has not complied with the publication requirements for foreign LLCs required by the New York Limited Liability Company Law.

As and for a Eleventh Affirmative Defense

13. That the alleged loans which are the subject of this action were usurious in that the effective rate of interest is in excess of the legal limit.

As and for a Twelfth Affirmative Defense

14. All causes of action alleged in the Complaint are barred by the applicable statutes of limitation.

As and for a Thirteenth Affirmative Defense

15. All causes of action alleged in the Complaint are barred by the defense of unconscionability.

As and for a Fourteenth Affirmative Defense

16. Plaintiff is barred from any recovery herein by the doctrine of unclean hands.
