ORDER	

This cause came before the Court pursuant to the Court's Order of March 13, 1983, for a hearing directing the Defendants Jim Watson and Deborah Wilder to show cause why they should not be held in criminal and civil contempt of this Court's Final Judgment of November 10, 1982 and Order of October 22, 1982 in this cause. Said show cause hearing was based upon the State of Tennessee's Motion and Affidavit attached thereto that were incorporated by reference into the Court's Order of March 13, 1983.

Said show cause hearing was held by the Court on August 8 through August 11, 1983, and based upon the testimony of the witnesses, the exhibits to their testimony, the argument of counsel and the entire record, the Court, for the reasons that are set forth in its findings of fact and conclusion of law that are incorporated herein by reference, finds beyond a reasonable doubt that Defendants Jim Watson and Deborah Wilder violated the Court's Order of October 22, 1982, and the Court's Final Judgment of November 10, 1982.

It is therefore ORDERED that the Defendants Jim Watson and Deborah Wilder be committed to the custody of the Sheriff of Shelby County and that Jim Watson be incarcerated in the Shelby County Jail for a period of one hundred seventy-five (175) days and Defendant Deborah Wilder be incarcerated in the Shelby County Jail for a period of one hundred (100) days. It is further ORDERED that Defendant James Watson shall pay five hundred thousand dollars (\$500,000.00) and Deborah Wilder shall pay Two Hundred Fifty Thousand Dollars (\$250,000.00) to the Clerk of this Court as civil penalties for said violations pursuant to Tenn. Code Ann. § 47-18-108(c). Upon Motion of the State for bonds pending appeal, said Motion is GRANTED and said appeal bonds are set in the amounts of Thirty Thousand Dollars (\$30,000.00) for Defendant James Watson and Fifteen Thousand Dollars (\$15,000.00) for Defendant Deborah Wilder. The original of said proposed Order has been filed with the Clerk of the Court for approval by any counsel.
